Core Funding Financial Reporting Requirements Information Sessions



Donegal County Childcare Committee will be hosting Core Funding Financial Reporting Requirements Information Sessions, both face to face and online, to present key information regarding the core funding financial reporting requirements during the transition phase for year 1 and year 2.

The information session will give an overview of what the new Chart of Accounts Reporting Requirement entails and an overview of the tools that will be available to you. It will outline the purpose of collating this information and the benefits of using these tools to record financial information about your service. Additionally, the session will outline the timeframe for completion of Chart of Accounts, the period of time they relate to, and what will be required going forward.

Always Children First - Foundation Training



The Always Children First Foundation training aims to create an awareness of Child Protection and Welfare issues in the Early Years sector. The aim of the training is to help participants understand how to safeguard children and report Child Protection and Welfare concerns.

This is a six hour programme and is facilitated by trainers from Donegal CCC.

A prerequisite of attending this training is that participants have completed the Tusla E Learning Children First Programme (within the last 12 months) and the Tusla Mandated Persons E learning. (The Mandated Person e-learning is a new requirement from 2024). CCC's will ask that participants send a copy of their certs to the CCC prior to attending the training.

DLP Training



This course is different to the Foundation Level Programme.

- The DLP course consists of 2 parts, part 1 is an online e-learning and part 2 is 3.5 hours long in person training.,
- Participants must complete the DLP e-learning within 2 weeks of the in person date.
- They must also have completed the Foundation Level withing 3 years of the training date.
- They must also have completed the Children First e-Learning and Mandated Person e-learning within 12 months.

Everyday Spaces



Everyday Spaces training for Early Years Educators will focus on how The National Participation Framework can enhance your work on involving babies, toddlers, and young children in decision-making in your everyday practice.

This training will refer to the United Nations Convention on the Rights of the Child and will explore practical approaches that can be applied in everyday decision-making in your early learning and care services.

Donegal County Childcare staff have been trained by Hub na nÓg to provide training on the National Participation Framework and Children's Participation in Decision Making in 'Everyday Spaces'.

AIM OF TRAINING

The aim of this training is for early years educators to demonstrate they can use the Everyday Spaces Checklist to ensure that babies, toddlers and young children are included in decision-making within their everyday work.

TRAINING AND LEARNING OBJECTIVES

On completion of the Everyday Spaces Early Years Educators training, participants will be able to:

- Describe the international and national rights, policy and legislative obligations of organisations in Ireland to involve babies, toddlers and young children in decision-making.
- Identify how the Participation Framework can support them to involve babies, toddlers and young children in decision-making in their everyday practice.
- Apply the everyday spaces checklist through using practical approaches to listening to babies, toddlers and young children and involve them in decision-making in everyday settings.


